If you switch to another option, you cannot transfer your money back to the Smoothed Return investment option. If you leave your employer, the treatment of your Smoothed Return investment amount will depend on your circumstances.*

Some members may be eligible to invest in the Capital Guarantee investment option under agreement with the Trustee. If this applies, you will be contacted prior to this investment switch being processed.

I understand that a switching fee of \$28 will apply if I have already made one switch using a *Change of Investment Choice* Form this financial year and that the Trustee reserves the right to limit the number of switches I can make each financial year if I am deemed to be switching excessively.

I understand that if this form is incomplete Energy Super will not be able to process my request.
